## COZUMEL REEFS NATIONAL PARK – ENVIRONMENTAL RULES

- Use biodegradable or non-oil sunscreen
- Do not touch or take any coral, shells, or marine life
- Gloves are not permitted
- Do not feed or harass marine life
- Maintain at least 10 ft / 3 m from corals
- Maintain controlled and proper buoyancy
- Cameras are **not** an excuse to break rules
